The minutes of the meeting of February 22, 2024, were approved as presented.

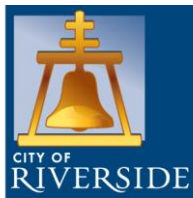
### ATTENDANCE

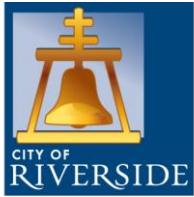
Chair Cavett provided a brief update on the Community Events Ad Hoc.
