Consequently, any item not listed on this agenda will normally have to be delayed until the item can be made part of a posted agenda. Additionally, significant changes to a project made subsequent to posting of the agenda and not addressed in the Cultural Heritage Board staff report will result in continuance of that item in order to allow for adequate review by the Board.

The City of Riverside wishes to make all of its public meetings accessible to the public. Upon request, this agenda will be made available in appropriate alternative formats to persons with disabilities, as required by Section 202 of the Americans with Disabilities Act of 1990. #### PUBLIC HEARINGS

2 PLANNING CASE P13-0361: Certificate of Appropriateness request by John & Jessica Dougherty for the proposed relocation of the historic Structure of Merit William A. Cooper House from 3690 Adams Street within the California Baptist University campus to the vacant northerly portion of the lot at 2909 Lime Street, located approximately 700 feet north of First Street on the northwest side of Lime Street in the R-1-7000, Single Family Residential zone, in Ward #1. It has been determined that, with mitigation, any potential environmental effects of this project will be reduced to a less than significant level based on the findings set forth in the case record, and a Mitigated Negative Declaration with mitigation monitoring and reporting program is recommended to be adopted pursuant to California Environmental Quality Act Section 21081.6.
