**PROJECT DESCRIPTION: PLANNING CASE P13-0361:** Certificate of Appropriateness request by John & Jessica Dougherty for the proposed relocation of the historic Structure of Merit William A. Cooper House from 3690 Adams Street within the California Baptist University campus to the vacant northerly portion of the lot at 2909 Lime Street, located approximately 700 feet north of First Street on the northwest side of Lime Street in the R-1-7000, Single Family Residential zone, in Ward #1.
